E. Reports to Committee

Zoo Report

Ronda talked about how the 2021 budget process is starting. The County asked the zoo to reduce GPR by 2.5%. The budget will be worked on over the next two months and the Commission will be able to see proposals at the next commission meeting. Ronda anticipates the Capital budget, which contains money for paving, HVAC, and other differed maintenance costs, to remain roughly the same. The Zoo will be asking for \$75k in medical equipment based on recommendations from the UW Veterinary School. Other anticipated costs include money to replace food storage coolers in the big cat and primate buildings and money for HVAC in the main gift shop.

ROSS asked about on ground revenue and what the loss has been due to the zoo's closure.

Ronda noted that zoo attendance since we reopened is about half of what it was last summer. While attendance numbers are down, gift shop revenue per person is up. We believe this is partly because product was moved outside to improve social distancing and reduce touch points. The Chocolate Shoppe per person revenue is also up, but sales in the Grille are down. It's still too early to know if these trends will hold all summer. The zoo has only been open since June 18. The Grille is working on improving contactless ordering/food pick up. The Grille has moved to 100% compostable packaging even while taking measures to keep customers safe during COVID.

ERICKSON asked about how donations have been since the zoo reopened.

Ronda said that donations have been up since we reopened and it is clear that guests are trying to help the zoo. We have a very supportive community. We have had almost 32,000 visitors since we reopened. The recent hot weather has resulted in lower attendance during the past week, but that is consistent with past years. Weather drives attendance.

ERICKSON asked if guests have been cooperative with the COVID measures the zoo put in place to reopen.

Ronda said most guests have been very cooperative. The zoo has been working with the County and the Department of Public Health and we do have free masks available for any guest who requests one. Animal masks are also available for purchase in the gift shop.

Ronda talked about how a 'We Missed You at the Zoo' campaign has just started to generate some of the revenue lost during our closure, but it just started so it is hard to project what the revenue will be. The zoo has decided to turn our September Zoo Run into a virtual race. Participants will be mailed a run t-shirt and will run their own course. Other zoos have had some success with this model because it allows people to participate from anywhere in the world.

Ronda said the zoo is still hopeful that we will be able to start a capital campaign next year for the Heart of the Zoo. We will need to focus on giraffe and rhino exhibits if we want to keep those animals in the zoo and maintain our AZA accreditation.

ROSS asked about what County support the zoo was getting.

Ronda said the County has been very supportive but understandably their main focus is on COVID issues at this time.

Ronda gave a staffing update. Two of our current staff members got bumped because of the Alliant layoffs, but the County came up with a plan to allow anyone laid off to work at COVID testing sites until the end of the year. We were able to move forward with hiring a second vet tech, which we have needed for some time. The County is also allowing the three previously approved animal care positions to continue.

Ronda gave an animal update. The giraffe SSP recommended moving one of our giraffes to a different facility, which leaves us with one giraffe currently.

ROSS asked if giraffes can be alone.

Ronda said it was typical of how a young, male giraffe would live in the wild and this arrangement gives our remaining giraffe more space. Ronda also talked about how we just got a second Bactrian camel, which is good because our current camel has been alone since his mom passed away last year.

ERICKSON asked about how the neighborhood has reacted to the zoo reopening.

Ronda said we have had about a dozen neighbors that we know of come through the zoo and we have had very positive feedback. We have increased trash receptacles and trash collection schedules to address their concerns from last year. We have a full time janitor now so our capacity to monitor parking lots has improved. We are very happy with how our relationship with the Madison City Parks Department is developing.
