Supervisor Jeremy Levin provided an overview of RES-102 for the commission. Reimer provided background on lake levels and Wisconsin Department of Natural Resources Water Level Orders. The orders provide for a six inch range in managing between the summer minimum level and summer maximum. Reimer also stated that the water level orders are a target and that rain events play the biggest role in the actual water levels that people see. Water is not able to move out of the lakes fast enough to constantly hold lake levels within the summer minimum and maximum. Commissioners recommended that the technical working group on flooding and lake levels reconvene.
