- --Updates: There has been an extension of the deadline to apply to be on the Redistricting Commission to encourage additional diversity on the commission. The deadline is September 11.
- MacKinnon gave a brief update and presented a map illustrating US Census response rate in WI (71%) and Dane County (77%).

Committee discussion on board size:

Erickson: Advocated for maintaining current board size or something very close to it as he wants to keep the current level of constituent engagement.

Chawla: Has no strong feelings about a change in board size. Size of county boards across the state seems to be a matter of "tradition" rather than population.

DeGarmo: Agrees 37 should continue to be the number but would be okay going a bit smaller only. Likes the "hyperlocal" decision making whereby each supervisor can have a personal touch with constituents.

Peters: Agrees that 37 is an okay size. If the board gets too small it would require full-time professional positions and he wouldn't want that/

Haasl: Agrees with same size or a bit smaller board to maintain community-based

decision making. 35 is a good number based on the raw public comments

Eicher: A larger board allows for more diversity and representation (e.g., campus district) but would recommend taking the opportunity to go a bit smaller to 35.

Chawla, Erickson: Where does the number 35 come from? rationale?

Eicher: Being able to maintain the spirit of anybody being able to run for the board and being on it without it having to be a full-time job. A slight reduction would not add too many more constituents to each district. It's consistent with the growth of Dane County and would add just a few thousand more people per district. It allows for 5 members per each standing committee.

A motion was made by EICHER, seconded by ERICKSON, that County Board Office staff draft a resolution for the County Board that recommends changing the size of the board from 37 members to 35 members, and directing the Redistricting Commission to draw new district maps for Dane County accordingly. The motion carried by a voice vote.
