THORESEN added that the Foundation for Dane County Parks has been very active in its role to support the volunteers and has distributed over \$30,000 in grants in the last two years.

# 1. Budget Update

RIPP stated that there were two 2021 Budget adjustments made by the County Board that are part of the Parks Budget area.

a) A \$2 Million grant appropriation was added to the County Budget specifically to support the City of Monona's purchase of the San Damiano property on Lake Monona. The restrictions with financial aid limits the property uses for more passive park and recreation along with storm water management. This budget amendment was done to create and independent grant project and not deplete the resources from the Conservation Fund Grant Program that support other communities and partner projects.

b) \$2 Million was added to the Flood Risk Reduction Fund for the purchase of lands to help with flood prevention.

# 3. Foundation Update - Projects and Grants

THORESEN provided an update on the Foundation's Grant program and the process used to select grant recipients. The Foundation has now hired two staff to help grow the capacity and provide program sustainability. Elisa Guerrero is a half-time Foundation Coordinator and Jess Hankey is a quarter time Fundraising Coordinator. These positions are sponsored through grants from the Madison Community Foundation and the Schlecht Family Foundation. The Foundation has brought together Dean Health and SSM Health together with Dane County for a three year program called "Healthy Parks Healthy You". The partnership will promote healthy lifestyles, outdoor opportunities, and protecting the environment. The Foundation worked with the Madison Community Foundation for a way to highlight MCF's 281 Legacy Members. The Pandemic cancelled their 2020 celebration in 2020, so they looked for an alternative way to promote Legacy members. The Foundation worked with Parks staff to secure a MCF Grant to purchase 281 trees that will be planted as Legacy Trees in 2021. The Foundation is continuing to seek grants to bolster the Accessible Piers Program. Current projects include the completion of the Wisniewski pier and access area at Salmo Pond, and updates at Babcock and Fish Camp.
