2. Behavioral Health Resource Center (BHRC) Update

The Chair recognized Simon from the Dane County Department of Human Services to present the Behavioral Health Resource Center update. Simon mentioned the BHRC launched in late November of 2020 and things are going well - there is a steady stream of community members reaching out to the BHRC. Simon provided several additional updates; most callers are 3rd party callers (professionals/providers and concerned others (parents/families/friends)) and most people are connecting to the BHRC by calling instead of electronic means. As of January 14th, 2021 there have been 70 unique callers and within the last 30 days there have been 4,000+ hits on the website. Callers are offered and connected to peer support resources. NAMI of Dane County is now co-located with the BHRC.

3. Initial Look at Intercept 2 and Review SIM Report Recommendations 2-9

Clark-Bernhardt reviewed the Sequential Intercept Model (SIM) and provided an overview of SIM Intercept 2 (Initial Detention/Initial Court Hearings).

Lieutenant Triggs provided a step-by-step overview of the booking process which is a component in Intercept 2.

Clark-Bernhardt went through recommendations 2-9 in the SIM report (see attachment) and there was discussion among subcommittee members.

Subcommittee members discussed and identified next steps/pathways forward:

- 1. CJC BH staff support will research peer supports across the model and provide findings in February*
- 2. Subcommittee members will reflect on their agencies policies and procedures in February and will work with CJC BH staff support to create a worksheet of agency priorities as it relates to Intercept 2*
- 3. Learn more about pre-trial services; how does pre-trial services intersect with mental health and substance misuse issues?; what is the current clientele?; how are referrals made?; etc.*
