James stated that Sally Wilmeth and Terry Geurkink have supported accessibility improvements in Dane County Parks for years. This donation will support the installation of kayak/canoe launching pier at Fish Camp County Park. This is the second donation in as many years, supporting the accessible piers initiative. The family has also funded accessibility projects at Stewart Lake, Babcock, and Festge County Parks and were instrumental in the development of the Jenni and Kyle Preserve, named in memory of their children who both died in the 1980s of a degenerative neurological disorder.

2020 PARKS 2020 FRIENDS GRANTS ACT-320

Stinson provided an overview of the Parks Friends Grant Program. Stinson stated that the program was funded for \$100,000 in the 2020 budget. The grants are cost-share grants 25% partner/75% County. The Grants are based on cash contributions for a project. Five grants were submitted and reviewed by staff. Staff is recommending approval of all five grants for a total of \$47,837.25. Staff are planning to provide another grant cycle in 2021 for the remaining \$52,162.75 in grant funding.

1. Capital Springs Recreation Area Trail Updates

James provided an update on bike/pedestrian trail planning work that is occurring within the Capital Springs Recreation Area. The main focus has been on the State Park to Waucheeta Trail connection. The trail connection was approved in the Capital Springs Recreation Area Master Plan that was adopted by the State and County in 2010. The Friends of Capital Springs Recreation Area, Wisconsin DNR, and Dane County Parks have been working on planning for the boardwalk phase of the trail connection. In 2020 the Friends donated funds for a wetland delineation to be completed. James stated that this project has long been supported by the Town. He stated that he has arranged a public meeting in February at the Town of Dunn to review the project and answer questions.
