### C. Action Items

1. Social Media: Udate/Discussion/Action

1.1.Message for Fall/Winter, Script topic choices included pruning oaks, pruning in prep for winter storms, planting oaks, de-icing salt. BARTELL will work on editing and get to Entercom before December 15 spending deadline.

A motion was made by SHORT, seconded by RITT, to approve the topics planning for spring planting and de-icing salts. The motion carried by a voice vote 7-0

2. Commemorative Tree Planting for Paul Rusk Zoom event memorial held online. RITT spoke to ALVES regarding donating and planting a tree. Rusk's mother will be coming from California in spring for the planting and memorial. Northside neighborhoods and the North Side Planning Council in spring will gather interested parties and Rusk's mother to plan. Possibility of a tree and a bench, pending permission from parks. EDDY suggests talking to City Parks staff, as she believes there is a no tree planting policy. RITT will connect with Alder Abbas. Want to make sure neighborhood associations have input as well. EDDY will make a preliminary contact with City Parks.

3. Dane County Housing Authority and Urban Tree Alliance tree planting program: Discussion/Action. UTA/DCHA grant (Jeremy Cain, UTA is contact) through WIDNR to improve diversity and tree canopy in underserved neighborhoods in Madison. ALVES recommends the TB explore a partnership, maybe with another educational component. Could this be a pilot to provide guidance to other communities for this model? EDDY mentioned, as part of their educational effort, Madison Urban Forestry Task Force is planning a position for public outreach. EDDY suggests a county level talk about combining projects and forces together to maximize impact including an online meeting with UTA. Also, organizations with volunteers and similar missions discussed. Potential points of contact: Nathan Larson at UW, 1000 Friends of WI founder Abe Lenoch. BARTELL will follow up with Jeremy Cain and ALVES.
