1. Chapter 14 Ordinance Amendments and Illicit Discharge Ordinance - Jeremy Balousek, LWRD Water Resource Engineering Division Manager

Balousek provided an update on changes made to the ordinances. The department is still waiting on approval from Corporation Council on changes made to Chapter 14. Balousek shared drafts of the ordinances with the Environmental Agricultural and Natural Resources Committee at their November 12th meeting. The tentative plan is to introduce both ordinances to the County Board in January 2021.

Balousek shared an updated draft of the Illicit Discharge Ordinance with the commission (see 2020 RPT-537).

Minks reported that nothing changed from the budget summary document shared with the commission at its 10/7/2020 meeting (see PRES-072 below). Additional budget items that were added related to LWRD include:

- \$2,000,000 in grant funding to the City of Monona for the purchase of the San Damiano property
- \$2,000,000 in additional funding for the Flood Risk Acquisition Fund to help build flood resiliency
