*Dane County Juvenile Court Administrator John Bauman, City of Madison Community Development Specialist Hugh Wing and Dane County Children, Youth & Families Division Administrator Martha Stacker provided overviews of Youth Justice and the Dane County Juvenile Court Program and of the Opportunity Youth Coalition. The presenters outlined priorities for the future and answered committee members' questions.*

## G. Reports to Committee

### 1. COVID-19 Vaccine Update

*Dane County Department of Human Services Deputy Director Astra Iheukumere reported that staff and residents at Badger Prairie Health Care Center received the first dose of the COVID-19 vaccine. Earlier this week, DCDHS learned the Wisconsin Department of Health Services had expanded its Tier 1a rollout of the vaccine to include social workers, case managers, child life staff, child welfare workers and Adult Protective Services workers. When including employees of POS agencies working with DCDHS, more than 1,000 individuals are eligible to receive the vaccine during Tier 1a. DCDHS submitted its numbers to the state today. The Dane County Department of Administration has not mandated that employees be vaccinated.*
