#### E. Presentations

Dane County Sheriff Kalvin Barrett and Commander Erik Fuhremann presented on the Narcotics Task Force. Commander Fuhremann explained that the task force is a multi-jurisdictional force established to stop the illegal distribution of narcotics. Commander Fuhremann described drug related arrests on the street and large scale level. Task Force work has also led to the seizure of firearms. Narcotic sales have evolved with the use of phones from drug exchanges occurring at drug homes to exchanges anywhere now (at malls, parking lots etc...).

Supervisor Bayrd asked for a copy of the authorizing Memorandum of Understanding. Supervisor Bayrd asked for data regarding racial disparities related to call-in tips. Supervisor Weigan asked where narcotics are coming from. Commander Fuhremann clarified narcotics are coming from all over now, including United States Postal Service and other parcel delivery services. There is a decrease in heroin and an increase in fentanyl. Chemists in Europe and Asia are able to mass-produce fentanyl. Methamphetamine can be produced all over. Supervisor Weigan asked what percentage is coming through the mail. Commander Fuhremann indicated there is no hard data on that, but there has been an influx. Supervisor Weigan asked what is needed for the Task Force to be taken to the next level. Supervisor Andrae asked about staffing levels. Commander Fuhremann indicated staffing levels have been consistent for 6 years. Supervisor Andrae asked about no knock warrants. Supervisor Bayrd asked whether there were other task forces. Commander Fuhremann clarified the Gang and Narcotics Task Force is now called the Narcotics Task Force.

Supervisor Bayrd described the work of the Subcommittee on Fines and Fees. A comprehensive review of fines and fees related to civil cases, criminal cases and human services was conducted. Included in the Subcommittee were: the Public Defender. Sheriff, District Attorney, Clerk of Courts, Presiding Judge of Dane County (or designees). After a thorough, months long analysis, ten recommendations were established. Among the recommendations is a uniform waiver system, whereby one waiver form can be used across Departments. Fines and fees should be waived in a uniform manner. A uniform system of communication with those fined, shall occur before fines and fees are sent to collections.

Supervisor Rockwell asked whether the cost of going to collections was higher than the amount actually collected. That has not been determined. Supervisor Rockwell asked who would absorb the cost of the fee waivers. Supervisor Bayrd responded that looking through a racial justice lens, reducing fees when appropriate is beneficial for Dane County citizens. Supervisor Weigand asked whether recidivism rates with regard to fees were examined and whether there is abuse of fee waivers. Supervisor Weigand asked for a report on the amount of fees waived.

Next meeting will be on September 14, 2021. Chair McCarville explained that September and October will be busy with budget meetings. All Tuesdays in October should be blocked off, they may or may not all be used for meetings.
