A ROADMAP TO REDUCING VIOLENCE

- Brown reported the District Attorney's Office took part in a mock jury trial at the Dane County Courthouse to determine if trials could be held following COVID-19 safety protocols and it was determined it would be extremely challenging to do so. Judges hope jury trials can resume in June, when a higher percentage of the population is vaccinated. The DA's Office received tentative trial dates for priority cases, many of which are sensitive crimes cases or cases with speedy trial demands. As the office constructed availability charts for judges and prosecutors, it started settling cases and for the first time in the past nine months, case counts dropped slightly. Brown shared a chart showing how Victim Services case counts have grown over the past four years. A total of 3,736 new case letters were sent to victims between May 2020 and January 2021 to explain their rights - a service mandated by Marsy's Law.

- Ginsburg reported Safe Harbor Child Advocacy Center was busy in January and February and expects more activity as children return to in-school learning.

- Pellebon reported the Rape Crisis Center (RCC) is having discussions with the Madison Police Department about instituting a process in which officers submit referral forms to RCC, a change that will allow the agency to connect with more victims. RCC will reopen offices beginning in April for half days.

- Barry reported all Domestic Abuse Intervention Services (DAIS) employees who wished to receive the COVID-19 vaccine have received their shots. The agency is providing vaccination information to clients. A Case Manager was hired recently and DAIS is recruiting a Case Management Coordinator. The helpline is extremely busy, with mental health, AODA, housing and legal advocacy issues generating the most activity. DAIS is expanding the number of staff in the office and clients are being seen by appointment. The lobby remains closed to the public.

- Merker reported Heart Consulting, which works with victims with intellectual and developmental disabilities, continues to provide services virtually and is experiencing a growing wait list. The agency is concentrating on providing more resources for parents and caregivers.

- Freeman reported the Dane County Department of Human Services (DCDHS) Adult Protective Services hotline remains busy. DCDHS frontline workers have been offered the COVID-19 vaccination and are doing in-person visits when appropriate. APS offices are not open to the public. One area APS continues to monitor is quality-of-care issues in some residential settings that can be traumatic or victimizing to residents -- a trend that has surfaced since state entities began administering long-term care programs.

- Kamoske reported 90% of Madison Police Department employees have received the COVID-19 vaccine. The Special Victims Unit (SVU) has been busy and expects case loads to increase with students returning to in-person learning. Two search warrants were executed recently on Interagency Case Assessment Team cases and two more are scheduled. SVU is preparing to enter cases into the Sexual Assault Kit Initiative database, allowing victims to see track the status of their kit.

- Crowley reported DCDHS doesn't expect to open offices to the public until July at the earliest. Crowley will distribute a Public Health Madison & Dane County report entitled "A Roadmap to Reducing Violence" to commission members.

- Statam reported most Anesis Therapy Center employees have received the COVID-19 vaccine and the agency is providing in-person services. A new service facilitator started at Anesis last week and recruiting in ongoing to fill another position. New staff members are being trained to provide Acceptance and Commitment Therapy to parents who are system-involved and need to meet the criteria for parenting training.

- McKinney reported the Madison Common Council's Public Safety Review Committee is currently considering two topics: body camera use by police officers and the use of tear gas.
- Kato reported the wait list for services at The Rainbow Project Child & Family Counseling & Resource Clinic is growing. Most staff members have received the COVID-19 vaccination and a re-entry committee is considering how to safely reopen the office as most services continue to be provided virtually. The Rainbow Project has entered into a partnership providing behavioral health services in Madison's Kennedy Heights neighborhood and has started providing behavioral health support for mothers with young children in the Northside Early Childhood Zone. Two new service facilitators were recently added, and a child and adult psychiatrist who is trauma informed and culturally proficient started with The Rainbow Project in February. More support groups for child care providers is a priority.
- Miyasaki reported Project Respect supported victims involved in a federal human trafficking trial in February in which victims could watch the proceedings via closed-circuit feed. The defendant was convicted.

2. Anti-Spyware Project Update & Next Steps

Barry reported that University of Wisconsin assistant professor Rahul Chatterjee is in the process of obtaining equipment and recruiting volunteers to launch an Anti-Spyware Clinic. The clinic would be a replication of one with which Chatterjee was involved in New York. The free clinic, which would operate one day per month, would require a referral. Potential locations discussed include DAIS, the Dane County Courthouse and the Dane County District Attorney's Office. Chatterjee has stated it's important for a potential spyware victim to be accompanied by an advocate who can help with safety planning. It's expected the clinic will be able to take up to five referrals per month.

Elder Abuse: All subcommittees continue to meet monthly. World Elder Abuse Awareness Day will be held virtually on 15 June 2021. The Domestic Violence in Later Life Conference is scheduled for 28 October 2021.

I/DD: Miyasaki provided a presentation on Respect Madison and human trafficking in February. Evidence suggests there's a high incidence of individuals with cognitive and developmental delays being trafficked. Discussions are ongoing about whether there should be a screen mechanism regarding trafficking when working with I/DD individuals, perhaps as a single question on long-term functional screens.

Child Abuse & Neglect: The Prevention and Early Intervention Subcommittee and Advocacy Subcommittee have combined. A series of virtual events to support caregivers and parents in an effort to prevent child abuse is being planned for May. The Mental Health Subcommittee will meet this month. An effort is underway to get professionals who make referrals together quarterly to share new programming offerings and openings. With more in-person learning returning, a group of teachers and CPS workers hope to reconvene. The Latinx Mental Health Coalition has joined the Children, Youth & Families Consortium. The Trauma-Informed Advisory Council is planning a summit for November.

Sexual Assault: April is Sexual Assault Awareness Month and the Rape Crisis Center plans a full month of programming around the theme "Centering Blackness as a Form of Self-Care and Collective Liberation." A virtual luncheon is scheduled for 9 April. Awards recognizing individuals' excellent work will be presented. A two-day training on human trafficking is scheduled for the first Thursday and Friday of October.
