Karin Peterson-Thurlow gave an overview of the factors being considered by the County Board Office as a part of the process of developing a policy for future hybrid County Board and committee meetings. See attached document.

Supervisor Wegleitner spoke in support of continuing hybrid meetings and has appreciated the greater accessibility and inclusiveness they have afforded. She recommended eliminating the 30 minute cutoff for comment submission.

Committee member Chawla indicated he found the virtual meetings advantageous in many ways, including providing more accessibility for working parents. He recommended consideration of a hybrid meeting approach that would continue to hold standing committee and other committee meetings virtually while having the option of in-person/hybrid meetings for the main County Board meetings.

Staff will bring an update on this process to the committee at one of its June meetings.
