Supervisor Bayrd spoke in support of the Sub 1 to 2020 Resolution 215. She said the reason it is coming before the Executive Committee is to indicate support for the federal George Floyd Justice in Policing Act since change should happen on the national level. She also indicated that in discussion with the Sheriff's Office, she learned the DCSO does not employ no-knock warrants for drug crimes in Dane County, but that DCSO uses it at times for safety in homicide cases.

The resolution was amended as follows:

At Line 49 add:

"BE IT FURTHER RESOLVED that the Dane County Board of Supervisors requests the Dane County Sheriff's Office to collect data on the use of no-knock warrants in Dane County and to report that information to the Public Protection and Judiciary Committee on a quarterly basis."

A motion was made by CHAWLA, seconded by BAYRD, that Sub. 1 to the resolution be amended as follows:

At Line 49, add:

"BE IT FURTHER RESOLVED that the Dane County Board of Supervisors requests the Dane County Sheriff's Office to collect data on the use of no-knock warrants in Dane County and to report that information to the Public Protection and Judiciary Committee on a quarterly basis."

Peterson-Thurlow indicated that the County Board survey of the public, staff, and electeds has indicated a strong desire to continue to have virtual meetings and hybrid meetings. The AV equipment upgrade will facilitate hybrid meetings (in-person and virtual simultaneously) held from CCB meeting rooms.

A motion was made by CHAWLA, seconded by DeGARMO, that the Resolution Requiring 2/3rds Vote be recommended for approval. The motion carried unanimously.

DISCUSSION AND POSSIBLE COMMITTEE ACTION ON PROPOSALS FOR PROGRAM EVALUATIONS

There were no Executive Committee member proposals for program evaluation topics from standing committees at this time, although Supervisor Bayrd indicated that PP&J has a possible program evaluation idea regarding fees and fines forfeiture cases, and will be discussing it at its June meeting. She will bring the topic back at the next Executive Committee meeting if PP&J wants to propose it as an evaluation topic.

MacKinnon spoke on a possible county parks and zoo access and equity program evaluation topic that would start in late fall and carry over into 2022 to capture different seasons at the parks. It would include demographic data collection, surveying, and best practices recommendations, which she has been developing with staff from those departments. The proposal topic was well-received by the committee members.

The Committee directed staff to initiate a program evaluation process for the parks and equity project (RFP, etc.)

MacKinnon also mentioned there are discussions ongoing with OEI about a possible program evaluation that would lead to a comprehensive language access plan. More information is necessary before a scope can be developed.

The Committee will keep this agenda item for its next meeting to hear from Sup. Bayrd and any other supervisors on scoped topic proposals.

UPDATE ON REDISTRICTING

Brian Standing, staff for the Redistricting Commission, gave an update. Given the delay in the census, the commission is using the extra time to bulk up the public engagement element of their work. They are working with Representable to create a more inclusive and accessible process.

The Commission is waiting to hear whether a state legislative proposal to extend the redistricting process into 2022 will move forward. Carrie Springer is tracking that legislation for the County Board.
