> Chair Bayrd presented on the latest draft of the Fines and Fees Committee's draft of its recommendations. Supervisor Wegleitner suggested proposing a recommendation that would require the RESJ tool be used prior to the creation of any new fee. Chair Bayrd, Ketchum and Baring supported the addition of the recommendation. Supervisor Wegleitner suggested that recommendation # 7 be revised for clarity. Davis suggested that a new recommendation be created that would propose avoiding the practice of "debt parking" which is when debt is created but not collected upon. Baring explained that "debt parking" or debt collections have an equal impact on someone's credit. Chair Bayrd suggested that the issue about "debt parking" was not explored appropriately, and therefore, should not be included. Supervisor Wegleitner provided more information. Judge McNamara proposed that #7 be removed from the list, and Supervisor Wegleitner agreed. Nelson proposed including a recommendation that allowed for an evaluation of the progress made to make fees more equitable. Chair Bayrd and Davis agreed to add such a recommendation. Davis suggested a change to recommendation #5 that would include "credit reporting agencies."

> Chair Bayrd presented on the agency specific recommendations. Chair Baird explained that the Director of Family Counseling supported eliminating certain fees. Supervisor Wegleitner questioned how the recommendation could be eliminated. Baring commented on the recommendation. Judge McNamara commented on the removal of the contempt hearing recommendation, and asked for clarification. Discussion ensued among Chair Bayrd, Judge McNamara and Supervisor Wegleitner.

Supervisor Wegleitner suggested an additional recommendation that would require an assessment of the fees charged by the Sherriff's Office in the jail's commissary. Discussion ensued among Chair Bayrd, Supervisor Wegleitner, Sparkman, Baring and Ketcham.

Chair Bayrd presented on Next Steps recommendations. Judge McNamara, Chair Bayrd and Baring discussed the recommendations.
