1. REDISTRICTING PROCESS UPDATE

Rachel Rodriguez, staff from the Dane County Clerk' Office and the Dane County Redistricting Commission, reported the following updates regarding the redistricting process:

1) Representable's software has been rolled out to the public to ask them to identify their communities of interest. They did a training on 7/15 and the program has gone live. Encouraging County Board members to make their constituents aware of this input opportunity and to participate themselves, as well.

2) Gov. Evers vetoed the bill that would have affected redistricting maps and timeline. This means that the Census Bureau will release its data to states in mid-August and counties could have the data by September 1 to start the mapping process.

Committee members asked clarifying questions re: whether state will take action on the timeline, how should supervisors give input on the process, etc. Rodriguez indicated that the Clerk's office would appreciate supervisors publicizing the process and input opportunities to the public.
