The next meeting of the Dane County Redistricting Commission will take place on Thursday, September 23, 2021 at 7:00 p.m. on Zoom. The major topic will be a public hearing on proposed supervisory district maps. By general consensus, the Commission agreed to take registrants in the order that they register, and to limit speakers to 4 minutes apiece. Questions from Commissioners and responses from speakers will not count against speakers' time. Commissioners will discuss and deliberate on proposed maps after the public hearing is closed.
