Brent McHenry presented the updated and revised funding application for the AEC lighting project. The subcommittee members were satisfied with the revisions and approved funding from the SMART fund for this project for an amount up to but not to exceed \$159,900.

A motion was made by RIPP, seconded by MCGINNITY, that the Action Item be approved. The motion carried by a voice vote.

# 2. DECISION ON A "RESERVE" SMART FUND, AMOUNT NEEDED, AND ANY 2022 BUDGET ACTION NEEDED

MacKinnon gave an update on the status of the fund. After the AEC project approved today, there remains an approximate \$30,000 in the fund.

The subcommittee is in agreement that the need for a regular, quarterly SMART Fund grant process has diminished since departments and divisions have incorporated a sustainability lens and understanding into their routine operations and budgeting for projects, etc.

Discussion ensued regarding the subcommittee's desire for the existence of a continuing reserve of SMART Funds to be available on an as-needed basis by application/proposal for unanticipated / emergency departmental sustainable capital project needs that were not foreseen or budgeted for.

Staff will no longer issue quarterly calls to departments for SMART Fund proposals and the subcommittee will meet during the year as-needed on an ad-hoc basis when needed to advise on county sustainability issues (e.g., guidance on sustainability campus, sustainability projects, etc.) or if an emergency grant is requested from the reserve .

The subcommittee suggested keeping \$100,000 in the reserve fund and that Supervisors Ripp, Erickson, Peters, and McGinnity would be the appropriate parties to move any budget amendment forward to accomplish this.

No motion was necessary.
