ARPA money for this year grant program allowed for different services to be covered as assist older adults. Some of these services were providing window A/C units to help with keeping a manageable living condition with the hot weather, Complete bathroom remodels to convert to walk-in showers, paying for some or all of Adult Day Care center, complete coverage for grandchildren attending day care for camps and assisting with paying for older adults to move to Independent Living centers.
