Appeal of denial on reclassification of Clerk I-II held by Leroy Brown (Pos # 3317).

In a 2-0 decision, the Reclassification Appeals Board recommended to uphold the denial of the reclassification. County Executive Parisi agreed. This denial is upheld.

The motion was made by WICK, seconded by OLSON, that the board enter into closed session.

The committee may go into a closed session for purposes of deliberations concerning a case(s) which is/are the subject of any judicial or quasi-judicial trial or hearing before the governmental body. The authority for a closed session for such purposes is s.19.85(1)(a), Stats. During the closed, the committee may also conduct discussions relative to considering employment, promotion, compensation performance evaluation data of any public employee over which the governmental body has jurisdiction or exercises responsibility. The authority for a closed session for such purposes is s.19.85(1)(c), Stats.
