Family Services serves the entire state with trained counselors who respond to calls, texts, and chats. The 988 Suicide and Crisis Lifeline has received over 10,600 calls originating in Dane County since their launch in July 2022, making Dane County the Wisconsin county with the third highest call volume. Some callers to 988 require or would benefit from further local support.
