UPGRADES TO DANECOM EISNER TOWER

Public Safety Communications' (PSC) maintains radio towers that allow the functionality of the DaneCom radio system. One of these towers is the Eisner tower located at 5419 Reeve Road in the Village of Mazomanie. US CELLULAR is currently replacing the tower with rental abatement provided by Dane County. Updated technology to the Eisner tower is being provided by DaneCom maintenance provider RACOM at a cost of \$302,116.02. This expense will be funded out of PSC's Capital budget and reimbursed by US CELLULAR within the 2025 budget year.

NOW, THEREFORE BE IT RESOLVED that Dane County does hereby approve the agreement between US Cellular and Dane County.

THIS ADDENDUM, made and entered into effective as of the date by which both parties hereto have executed this document, by and between the County of Dane (hereinafter referred to as "County") and RACOM (hereinafter, "Provider").

WITNESSETH:

WHEREAS Provider and County, by a separate document (hereinafter, the "Master Agreement"), Dane County Contract # 14911, have previously entered into a contractual relationship pursuant to which Provider provides DaneCom Radio System Maintenance, and

WHEREAS County and Provider wish to amend the Master Agreement in order to include the purchase of Tower Mounting Cabling & Miscellaneous Equipment AND Implementation Services for the Eisner Tower located at 5419 Reeve Rd in the Village of Mazomanie.

NOW, THEREFORE, in consideration of the above premises and the mutual covenants of the parties hereinafter set forth, the receipt and sufficiency of which is hereby acknowledged by each party for itself, the parties do agree as follows:

1. The Master Agreement shall remain in full force and effect unchanged in any manner by this addendum except as changes are expressly set forth herein. This addendum shall control only to the extent of any conflict between the terms of the Master Agreement and this addendum.
2. The Master Agreement, and any amendment or addendum to it, may be executed and transmitted to any other party by legible facsimile reproduction or by scanned legible electronic PDF copy, and utilized in all respects as, an original, wet-inked manually executed document. Further, the Master Agreement and any amendment or addendum thereto, may be stored and reproduced by each party electronically, photographically, by photocopy or other similar process, and each party may at its option destroy any original document so reproduced. All parties hereto stipulate that any such legible reproduction shall be admissible in evidence as the original itself in any judicial, arbitration or administrative proceeding whether or not the original is in existence and whether or not such reproduction was made by each party in the regular course of business. This term does not apply to the service of notices under the Master Agreement, or any subsequent amendment or addendum.
3. The purchase of Tower Mounting Cabling & Miscellaneous Equipment is as follows:
 - (4) 4 Dipole 8.5dB Antennas (138 - 174 MHz)
 - (4) 8 Dipole 11.5dB Antennas (138 - 174 MHz)
 - (1) 5 Element 9.2 dB Directional Antenna (450 - 470 MHz)
 - (1) Omni Dipole 8.1dB Antenna (150 - 160 MHz)
 - (1) 6' Parabolic Dish (5.925 - 6.425 GHz)
 - Ancillary Cabling, Connectors, uWave, and Miscellaneous Equipment

AND Implementation Services as follows:

- Site Surveys
- Equipment, Installation, Site Management, and Commissioning
- Functional Testing
- Project Coordination & Status Updates

for a total cost of \$302,116.02. All parts shall be maintained and warrantied by RACOM in accordance with the existing Master Contract.
