Colleen Clark-Bernhardt introduced ATTIC presenter Mia Widhalm. A presentation on the ATTIC program. Program adds to diversion options in Dane County Courts and offers nonprofit community service support for defendants serving a 30 day or less jail stay. Focus on outcomes and impact of the program.

Discussion ensued regarding program capacity and availability, court branch referrals, potential program growth, terminations and patterns in program success/failure, extension program eligibility, ability to follow-up post program, long term benefits and ties to recidivism, and potential for tracking and sharing data on participants and hours.

Measurement and analysis requested around the need for helpful metrics in behavioral health data linking to criminal justice system, and potential for database showing needs of population and nature of the conduct/offenses to be accessible by different agencies. The need for shared vocabulary, metrics and goals in assessing outcomes and success.

Searching for other actionable areas in data, need for more qualitative data, access to diversion and other programming along with usage rates, and risk aversion by anonymizing data while still tracking outcomes.

Gaps, barriers and wait times in reentry/reintegration and request the CJC-Racial Disparities subcommittee review objectives and tactics in the CJC strategic plan under reentry. Potential for national partner, CSG, to assist in framing the work of reentry via REENTRY 2030. Staff will follow up with action and any request for letter of support from CJC members.
