Site Host RFPs Update

EV Advisory Commission Meeting (September 15, 2025)

The Dane County Office of Energy & Climate Change (OECC) issued a Round 2 Request for Proposals (RFP) seeking site hosts for the Charge Up Dane County effort on August 21 with a September 30 deadline. This is a quick summary of the status of our two rounds of site host RFPs.

Status of Round 1 RFP

The bottom line is that we've identified 33 sites to move forward into design.

We received 57 site host applications, of which 51 met at least one of our grant priorities.

Our design team, KL Engineering, did **desktop reviews of all 51 qualified sites**. Then KL did **in-person visits to 48 of those sites**. (We put 3 sites on hold that were, for one reason or another, unlikely to be viable.)

Following the desktop reviews KL met with OECC staff to review each site, assessing the level of difficulty associated with the installation. OECC authorized **33 sites to move forward to preliminary design**. KL is currently completing the required NEPA paperwork and a 30% design with cost estimate for each of those 33 sites. At the same time OECC staff is finalizing site host agreements with each site host. We need all of that information in order to submit a request to FHWA for the construction funding for those sites.

Round 2 RFP

The Round 2 RFP is currently open with a deadline of September 30, 2025.
