Marco Juarez, Coleman Consulting Group, presented the findings and recommendations from this project. The report and presentation are attached in the presentation file. The discussion can be viewed on the meeting recording.

Committee members engaged in questions and discussion with Mr. Juarez during the presentation. Supervisors asked where the data came from and the presenter indicated that the data was gathered from multiple forms of engagement with the DC PSC communicators and other PSC personnel.

Christopher McNett, PSC Communicator registered and commented that they would prefer as many 8-hour shifts as possible.

Presenter and other PSC EGR staff commented that 8-hour shifts were considered in the analysis but that evidence points to mixed shifts not working and adding to scheduling inequity between workers in the end.

The final report will be posted to the Dane Co Bd of Supervisors' reports tab on its webpage. CCG will do some follow-up work with PSC regarding implementation of recommendations before wrapping up.
