AUTHORIZING HIGHWAY SAFETY GRANT FUNDING FOR AN IMPAIRED DRIVER ENFORCEMENT TASK FORCE

Policy Analysis Statement:

Brief Description of Proposal -

The Department of Transportation, Bureau of Transportation Safety, State of Wisconsin, is providing \$190,000 grant funding for participation in a 2024/2025 Impaired Driver Enforcement Project, Grant Number IDE-2025-DANE CO SO-00145; grant project period is October 1, 2024 through September 30, 2025; the Sheriff's Office shall receive \$95,000 and the Madison Police Department shall receive \$95,000 grant funding.

Current Policy or Practice -

Acceptance of grant funding requires approval of the County Board.

Impact of Adopting Proposal -

In Wisconsin during 2023, alcohol was listed as contributing factor in vehicle crash deaths. Creation of a Multi-Jurisdictional Traffic Safety Task Force with the Dane County Sheriff's Office and the Madison Police Department will provide a comprehensive strategy for combating impaired driving in Dane County to reduce crashes which cause significant injury or death.
