1. Federal Medicaid Cuts - Resolution

Fischer said there are reports that there are going to be cuts to the Federal Medicaid Budget. Reports by media have said Congress intends to cut Medicaid to offset spending for other priorities.

Fischer shared a draft resolution that urged Congress to not make dramatic cuts to Medicaid and the American Act funding.
