Dear Aaron and Brian,

Thanks for the draft you sent. Here are my initial comments:

Overall, I like the changes.

My Town's Plan Commission met recently for discussion of our own pending Comprehensive Plan update. There were some concerns/questions by folks supportive of history (and prehistoric) preservation. They wondered out loud about how much the Town could rely on County and the Wisconsin Historical Society to do what they say they're going to do in terms of the review and consulting referenced in the new para. 3 of the "Policies and Programs" section of the draft. As a town, we will have to continue to put our trust in others' good-faith efforts. In cases where it's determined that petitions and permits do not impact protected resources, what would help to allay our concerns is to see a specific statement in the County's approval (or disapproval) documentation that the promised review and consultation have been undertaken and the results were negative for protected resources - in other words, an affirmation rather than just an assumption.

I will not comment on the "Rustic Roads" item. Our town has no designated rustic roads, and I am not at all familiar with that program.

As for achieving a quorum for our September 12th meeting, I do intend to participate by Zoom to the extent that the technology will permit. That day I will be driving from Madison to the Kenosha area, with a disabled friend in the car. I've arranged with him to pick him up before our meeting starts and to arrive at our destination about the time for our scheduled adjournment.

Finally, pursuant to your instructions, I am sending this email to you two directly, and not to any other committee members.
