**Policy Analysis Statement:**

Brief Description of Proposal -  
This resolution authorizes an agreement award of \$230,000 to Centro Hispano, Inc.

Centro Hispano, Inc. will explore the feasibility of expanding Centro services to middle and high school youth who live in communities outside of Madison. This grant agreement also provides for Centro to expand programming to elementary age children.
