# Policy Analysis Statement:

#### Brief Description of Proposal

This resolution would approve a submittal application to establish a Foreign-Trade for the approximately 10.45-acre site of Tekni-Plex Flexibles, LLC's present operations in Madison, Wisconsin. Tekni-Plex Flexibles, LLC imports films and applies a proprietary coating to the rolls which are then used throughout the medical market in the packaging of sterile products and devices. Tekni-Plex Flexibles, LLC intends to use the subzone site for operations including manufacturing, warehousing, and distribution of medical and healthcare products.

### Current Policy or Practice -

Dane County has established a Foreign Trade Zone, No. 266, and acts as the grantee and administrator.

## Impact of Adopting Proposal -

TekniPlex Flexibles, LLC will be approved to submit an application to be granted subzone status for operations including manufacturing, warehousing, and distribution of medical and healthcare products. Tekni-Plex Flexibles, LLC will pay one-time costs for the application and activation fees in 2025, plus an annual fee.
