Severity of Offense and Criminal History

The nature of the criminal offense, as well as the criminal history of the resident, will not be a consideration for eligibility into the 3 year CAMP Pilot Program.

Domestic Violence Crimes Guidelines

If the current sentence being served is a domestic related charge, the resident cannot live with the victim. A residence restriction will also apply if there is a domestic history within the last 3 years, regardless if it's a current or pending charge. The CAMP supervisor must approve any requested exceptions.

Active Injunctions – Exclusionary Zone Current or Pending Domestic charges – Exclusionary Zone

Alcohol Related Crimes

All residents should be evaluated for an alcohol monitor. OWI 4th Offense or greater, OWI Injury, OWI W/Child Under 16yrs Old, multiple/concurrent OWI offense, or alcohol related sentences greater than 30 days should have an alcohol monitor.

Individuals on case management or individuals who report to jail with detectable signs of using alcohol will be evaluated for an alcohol monitor and case management.

Jail Behavior History

Institutional behavior is taken into consideration when determining an individual's appropriateness for the CAMP Program. In certain cases, a resident may be required to remain in jail for a time period to allow the staff to assess the subject's behavior and willingness to follow the jail rules.

Sgt. Review:

- -Violence or threat of violence against Jail staff
- Behavior, which poses a great risk to Jail security
- Excessive disciplinary entries
- -Multiple/recent disciplinary hearings
- Security Class MD/BP or MX/BP
- -Current/recent AC

Probation and Parole Supervision

Probation and Parole will be notified regarding their client's participation in CAMP. Notification can be done by phone or email. Probation and Parole emails are firstname@wisconsin.gov

Housing

All housing must be approved by CAMP staff. Roommates/family must agree to the monitoring conditions. Housing must be in Dane County unless approved by Jail Administration. Electrical services must be uninterrupted and capable of supporting the monitoring equipment. The resident is required to have a landline or cell phone while on the program. Housing may be denied if it presents a risk to the subject, anyone living at the residence or our staff.

Employment

Employment is not required to be eligible for CAMP. Subjects who are employed or seek employment while on CAMP will follow all DCSO Huber law procedures.

Transfer Requests

Transfer requests are subject to the approval of the Jail Administration.

Drug Screen

Resident's must provide a negative urinalysis before going out on CAMP. Resident's may only possess medications prescribed by a physician.

Individuals who report to Jail with detectable signs of using drugs and/or alcohol will remain in Jail and be re-tested at standard times. These standard times are not only based on the rate these substances metabolize in the human body and the earliest potential time they can produce a negative test for those substances, but will also give our medical staff time to monitor these subjects for possible signs of withdraw from these substances. The CAMP social worker may also make contact with these individuals during this time to discuss and develop case management if needed. The standard waiting periods are 10 days for THC and 5 Days for all other drugs and alcohol.

Diversion Fees

Resident's should pay their fees at the requested times. Failure to do so may result in disqualification from the program. If the resident is unable to pay the fees associated with diversion, they can apply for the indigence fund or be eligible for reduced fees. The inability to pay fees will not be a barrier for eligibility into the CAMP program.

Diversion Orientation

Subjects must report to their CAMP orientation on their scheduled date and time. Subjects who report for orientation under the following conditions will have their status for CAMP reviewed:

- -With detectable signs of using drugs and /or alcohol.
- -Who are uncooperative with the CAMP staff.

Reporting to Jail

Subjects must report to Jail on their scheduled date and time. Subjects who report to jail under the following conditions will have their status for CAMP reviewed:

- -With detectable signs of using drugs and /or alcohol will have alcohol monitor
- -Who are uncooperative with the CAMP or booking staff.

CAMP Violations

Any violation of CAMP rules and regulations, law, or municipal ordinance may result in the loss of privileges, loss of good time, revocation of Huber privileges and/or removal from CAMP.

Case Management

The CAMP Social Worker will review every CAMP applicant for case management. If needed the social worker will assess the needs of the subject and will help arrange, coordinate, monitor, and evaluate for multiple services in order to meet the client's needs.

Criteria Waiver

The Security Services Captain or his/her designee has the right to waive any or all CAMP requirements for reasons of safety and security, Jail operations, or specials needs.
