# Dane County's Aging Population

From 2020 to 2050, Dane County's age 60 and over population is projected to grow by 50.9%.

# Key Takeaways from 2025

- AAA supported core services across nutrition, transportation, caregiver support, wellness, benefits counseling, and case management
- County investment remained essential, especially for case management and local matching requirements
- Community-based and culturally responsive programs helped extend reach and responsiveness
- Demand pressures continue in transportation, complex needs, and support for aging in the community

# Older Americans Act Title III



- Major source of funding for local aging services
- Prioritizes older adults with greater social or economic need
- No income or asset test
- Voluntary contributions only
- Counties must provide a match

# AAA Supports Essential Services Such As:

- Senior nutrition programs
- Transportation for medical appointments and daily needs
- Caregiver support and respite services
- Health and wellness programs
- Benefit Counseling
- Case management

# SENIOR NUTRITION

- 270,449 meals served
- 5,181 older adults reached
- 26 Sites + Home Delivered meals  
Countywide
- 450 volunteer drivers
- 32 nutrition counseling recipients
- 2000+ received nutrition  
education
- 985 Farmers market voucher  
recipients



# TRANSPORTATION

- \$556,870 in county levy leveraged an additional \$1,560,361 in other funds
- **221,035** rides provided
- Supported access to medical care, meals, groceries, and community programs
- In addition, connected people with their community to combat loneliness and isolation as well as helped low-income individuals search for work.

# National Family Caregiver Support Program 2025

- Caregiver Grants provided to 80 caregivers totaling \$86,345.
- Provided Coordination and Connection of about 200 Caregivers with Caregiver Support Groups & Services
- Education about Caregiving Issues & Opportunities Newsletter – “Caregiver Chronicles”

# Evidence-based Disease Prevention and Health Promotion Services

## High level evidence-based

- **Falls Prevention (Safe Communities Contracted Agency)**
  - Stepping On - 124 seniors with 13 workshops offered across Dane County
  - Stepping Up Your Nutrition offered at four Stepping On workshops
  - Collaborated with NewBridge Senior Center to offer Pisando Fuerte
- **Chronic Disease Self-Management Programs (unfunded, but coordinated by AAA)**
  - Mind Over Matter; Healthy Bladder, Healthy Bowel
  - Healthy Living with Chronic Pain

# ELDER BENEFIT COUNSELING

Legal Services - Elder Benefit Specialists served:

- **276** clients with
- **2,088** hours of service
- resulting in a gain of **\$1,268,354** in benefits to older adults served

# OTHER AGING SUPPORT PROGRAMS

- ▶ The Area Agency on Aging has other contracts which support community-based and culturally responsive approaches for:
  - ▶ Inclusion and belonging
  - ▶ Culturally specific services
  - ▶ Aging in place and safely
  - ▶ Mental health and decision-support services

# CASE MANAGEMENT

- **FY 2025: \$1,853,301 County GPR**
- **County-funded service supporting older adults to remain independent in the community**
- **Dane County is the only county in Wisconsin with this model**
- **12 Focal Point contracts**
- **3,230+ adults served; 23,500+ service hours**

# Funding Sources

## Federal & State

- Federal grant allocation (based on population formulas)
- State grant allocation (based on population formulas)
- Nutrition Services Incentive Program (NSIP-USDA)
  - Reimbursement for each eligible meal served in the prior fiscal year

## Local

- County GPR/tax levy
- County match
- Donations from private foundations, local civic groups, businesses, etc.
- Grants
- Gifts/bequeaths

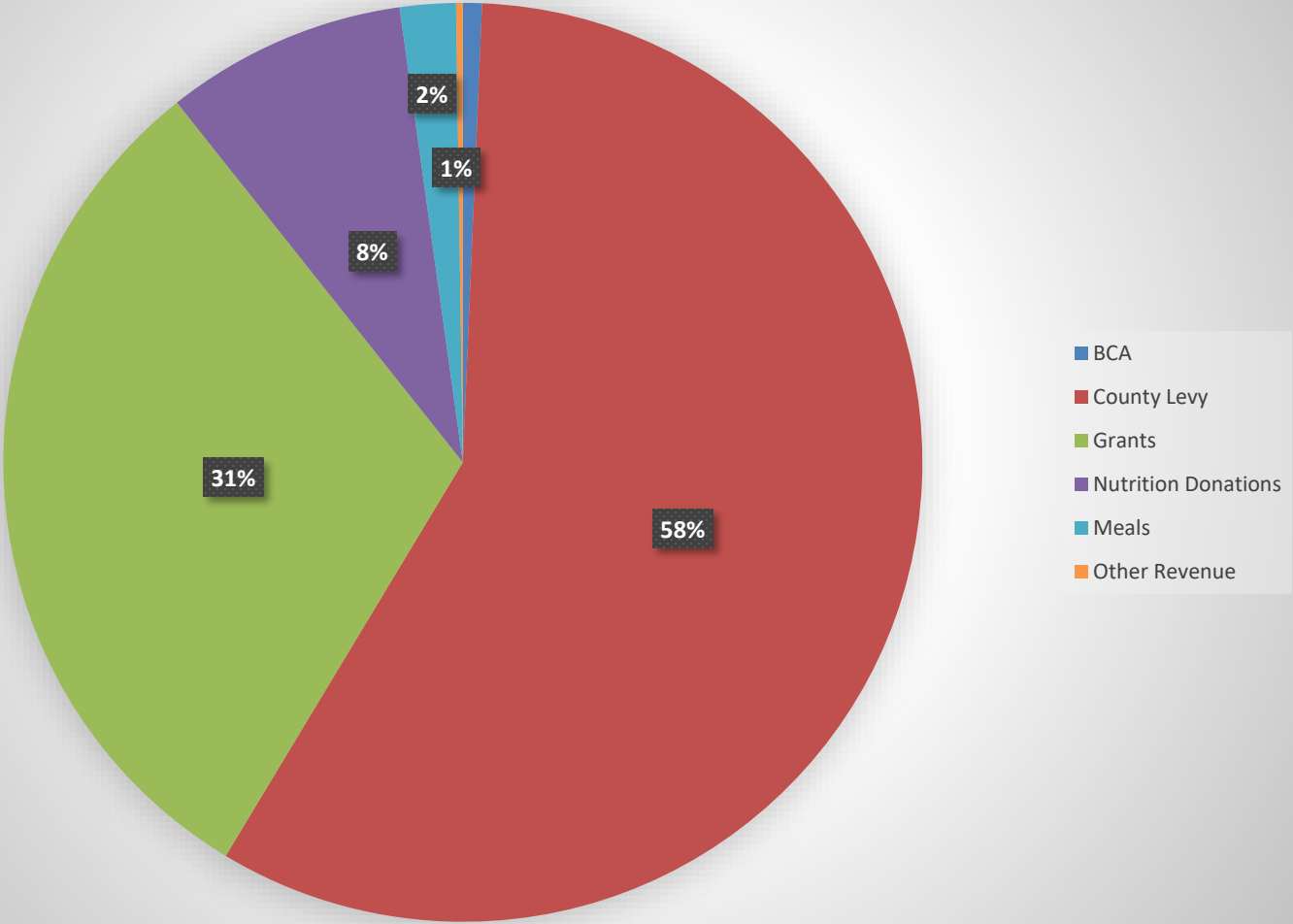
## Program Income / Contributions

# AAA Governance and Guidance

- Governing Board
- Advisory Council
- Standing Committees

# Role of the AAA Governing Board

- Approves the Aging Plan
- Monitors programs and contracts
- Identifies community needs
- Provides advocacy and public information
- Advises county leadership
- Approves community grant awards.

# Role of the AAA Advisory Council

- Provides input and recommendations
- Advises on the Area Plan on Aging
- Identifies unmet needs
- Supports coordination of community-based aging services
- Connects AAA with community voices
- The Council is an advisory body, not a final decision-making body.

# Other Committees:

- **Grant Review and Selection:**
  - Reviews and scores community grant applications
  - Recommends awards to the AAA Board
- **Nutrition/Wellness:**
  - Advises staff on nutrition services
- **Advocacy/Legislative:**
  - Reviews policy issues affecting older adults

# Looking Ahead: Issues and Priorities

- Sustain core services amid growing and complex need
- Maintain county-supported case management capacity
- Continue culturally responsive and community-based outreach and nutrition services
- Strengthen transportation, caregiver support, and access to benefits
- Use board, advisory, and committee structures to guide priorities and accountability



# What AAA support Looks Like for Dane County Residents

An older adult living alone begins to struggle with transportation, meal preparation, and managing on a fixed income. Through the Area Agency on Aging network, the resident is connected to home-delivered meals, transportation assistance, elder benefit counseling, and case management. With those supports in place, the resident is able to remain safely at home, attend appointments, improve financial stability, and stay connected to the community

# Another example:

- Adult daughter caring for her mother at home
- Balancing work, appointments, and daily caregiving
- Feeling overwhelmed and unsure what help is available
- Connected through AAA to:
  - caregiver grant support
  - caregiver support group and education
  - transportation assistance for Mom
  - case management and service coordination
- Result:
  - less caregiver strain
  - better support for the older adult (Mom)
  - greater stability at home
