# ACCEPTING ADAW DONATION AND CREATING NEW LINES DCDHS – DAS DIVISION

### **Policy Analysis Statement:**

## Brief Description of Proposal -

This resolution authorizes the acceptance of new funds from the Alzheimer's and Dementia Alliance of WI (ADAW), the creation of new lines in the budget and position authority to be increased by .50 FTE for a Dementia Support Specialist Project position.

## Current Policy or Practice -

Budget changes and changes in position authority require County Board approval.

### Impact of Adopting Proposal -

DAS Division will be managing the Alzheimer Family Caregiver Support Program internally for the remainder of 2023 that was contracted to ADAW through a POS contract. A .50 LTE will be hired for the remainder of 2023 to ensure families receiving grants through this program are supported. For this reason, an LTE expense line is being requested. Position authority will be increased by .50 FTE.
