AGREEMENT FOR THE JURISDICTIONAL TRANSFER OF COUNTY HIGHWAY BB FROM BUSS ROAD TO DAMASCUS TRAIL WITHIN THE VILLAGE OF COTTAGE GROVE AND TOWN OF COTTAGE GROVE

The Dane County Highway & Transportation Department and representatives of the Village of Cottage Grove and Town of Cottage Grove wish to formalize the transfer of jurisdiction of a portion of CTH BB within the corporate limits of the Town and Village.

The limits of this transfer are from the western end of the Buss Road intersection easterly to a point at the center of the intersection with Damascus Road, a distance of .47 miles.

NOW THEREFORE BE IT RESOLVED that the County Executive and the County Clerk be authorized and directed to execute this jurisdictional transfer agreement on behalf of Dane County, with the Village of Cottage Grove and the Town of Cottage Grove.

# AGREEMENT FOR THE JURISDICTIONAL TRANSFER OF COUNTY HIGHWAY BB FROM BUSS ROAD TO DAMASCUS TRAIL WITHIN THE VILLAGE OF COTTAGE GROVE AND TOWN OF COTTAGE GROVE

This Agreement ("Agreement") is made and entered into by and among the County of Dane, a Wisconsin quasi-municipal corporation ("County"), the Village of Cottage Grove, a Wisconsin municipal corporation ("Village"), and the Town of Cottage Grove, a Wisconsin municipal corporation ("Town"), collectively referred to as ("the Parties").

### RECITALS

WHEREAS, the Parties wish to formalize the transfer of jurisdiction of a portion of County Highway BB within the corporate limits of the Town and Village, more particularly described in Section 1, from the County to the Village; and

WHEREAS, the County obtained permission from the Wisconsin Department of Transportation as required by sec. 83.025(1)(a), Wis. Stats., to delete the portion of County Highway BB from its County trunk highway system on May 2, 2024; and

WHEREAS, the Town consents to the Village taking jurisdiction over County Highway BB (as defined below) within the corporate limits of the Town so long as the Village performs all construction, maintenance, and upkeep of County Highway BB; and

WHEREAS, pursuant to Wis. Stat. § 66.0301 the Parties wish to formalize the jurisdictional transfer of the identified portion of County Highway BB to the Village;

**NOW THEREFORE**, in consideration of the above premises and the mutual covenants of the Parties hereinafter set forth, the receipt and sufficiency of which is acknowledged by each party for itself, the Parties do agree as follows:

### **AGREEMENT**

- This Agreement pertains to the portion of County Highway BB from the western end of the Buss Road intersection easterly to a point at the center of the intersection with Damascus Road, a distance of .47 miles. This portion is referred to as "County Highway BB" in subsequent sections of this Agreement.
- 2. The Village will take jurisdiction of County Highway BB effective August 1, 2024. Upon taking jurisdiction of County Highway BB, the Village shall have full control and responsibility over County Highway BB. Upon the jurisdictional transfer:
  - a. County Highway BB shall be deleted from the county trunk highway system.

- b. All regulatory authority and responsibility of County Highway BB shall be transferred to the Village, including, but not limited to, all access rights and permitting control. The Village Police Department shall have jurisdiction over County Highway BB.
- c. Any State of Wisconsin or federal aid associated with County Highway BB shall be transferred to the Village upon completion of the transfer of jurisdiction.
- d. The parties shall make State of Wisconsin levy adjustments to reflect the jurisdictional transfer.
- 3. The Village shall be responsible for all County Highway BB maintenance, repairs, improvements, snowplowing, street sweeping, and any other responsibilities customary for maintaining a highway, including the portion of County Highway BB located within the Town. The Village shall perform all of these duties in accordance with its standards for Village streets.
- 4. Each party shall be responsible for the consequences of its own acts, errors, or omissions and those of its employees, boards, commissions, agencies, officers, and representatives and shall be responsible for any losses, claims, and liabilities which are attributable to such acts, errors, or omissions including providing its own defense. In situations including joint liability, each party shall be responsible for the consequences of its own acts, errors, or omissions and those of its employees, agenda, board, commissions, agencies, officers and representatives. It is not the intent of the parties to impose liability beyond that imposed by state statutes. The obligations of the parties under this paragraph shall survive the expiration or termination of this Agreement.
- 5. Each party warrants for itself that it has complied with all necessary requirements to execute this Agreement and that the person executing this Agreement on its behalf is authorized to do so.
- 6. This Agreement may be amended in writing upon agreement by all parties.
- 7. This Agreement may be executed in one or several counterparts, which together shall constitute a single instrument.
- 8. The effective date of this Agreement shall be the date on which all parties have signed the Agreement.

IN WITNESS WHEREOF, the parties have executed this Agreement.
