Update on Recommendations and Resolutions from 2024 and 2025

Supervisor Wegleitner spoke on Resolution – 143 that it has passed the County Board and has been signed in by the County Executive. Funding for 2024 was for the Harm Reduction and Drop-In Center and additional staffing for Public Health of Madison and Dane County, totaling \$800,000. The 2025 Recommendation and Resolution is focusing on the Drug Court Program and the Drug Court Program is NOT funded by the Opioid Settlement Funds.

Aurielle Smith spoke on behalf of Public Health of Madison and Dane County the next step is for positions to be created and will go through the legislative process, hoping to see some updates or progress by February or March."

Update on Settlement Subcommittee Funds

Chair Rose spoke on the 2025 Budget, including funding for 3 Public Health positions, allocated in 2024 Resolution-143. This should leave around \$1.35 Million or around \$800.000 to be allocated for 2025.
