AMENDING CHAPTER 41 OF THE DANE COUNTY CODE OF ORDINANCES, REGARDING LANDFILL FEES

The County Board of Supervisors of the County of Dane does ordain as follows:

ARTICLE 1. Unless otherwise expressly stated herein, all references to section and chapter numbers are to those of the Dane County Code of Ordinances.

ARTICLE 2. Section 41.115 is amended to read as follows: **41.115 USER FEE SCHEDULE.**

- (1) The standard fees for allowable solid wastes at Landfill No. 2 (Rodefeld), for which no special fee has been established, shall be assessed at a rate of \$475.00 per ton of material deposited, plus all applicable State imposed fees.
- (2) Special fees for asbestos, and mixed shingles, and other special wastes as determined by the Director, at Landfill No. 2 shall be \$697.00 plus all applicable fees. In addition to the fee set forth in this subsection, Mmaterials that require special handling or waste profiling may be charged additional fees based upon actual costs to the Department not to exceed \$2500.00
- (3) The standard fees for deposit of allowable materials at Landfill No. 2 or the Construction and Demolition Recycling Facility shall be assessed at the following rates:

(4) Loads of waste deposited at Landfill No. 2 or the Construction and Demolition Recycling Facility weighing less than 1 ton (2,000 pounds) shall be assessed a prorated flat fee at the following rates:

Weight of Load Deposited	Flat Fee (% of per ton rate)
Less than 500 lbs.	25%
500 lbs. but less than 1,000 lbs.	50%
1,000 lbs. but less than 1,500 lbs.	75%
1.500 lbs. but less than 2.000 lbs.	100%

- (5) Notwithstanding the rate set forth in subs. (1) & (3), the rate for high volume users shall be \$434.00 per ton, plus all applicable state imposed fees for solid wastes deposited at Landfill No. 2. This rate does not apply to landfilled solid wastes with special fees.
- (6) Notwithstanding the rate set forth in subs. (1) & (3), the rate for high volume users shall be \$564.00 per ton, plus all applicable state imposed fees, for construction and demolition debris deposited at the Construction and Demolition Recycling Facility.
- (7) As used in subs. (5) & (6), *high volume user* means an entity that has deposited at least 500 tons of waste or recyclables at the site in each of the 6 months immediately preceding the month in which this subsection is applied.

The fee for Households and Farms is for disposal of all household hazardous waste and miscellaneous electronics in a single residential or farm load. Dane County reserves the right to charge additional fees for excessive sized loads. An additional fee will be charged for disposal of certain electronic devices as follows:

Microwave Oven \$10.00 Television or Computer Monitor \$15.00 Large Appliances \$35.00 Appliances containing refrigerant \$35.00
