



The CJC of Dane County provides the work plans for data centered projects/analysis with the general oversight of the Director. Multi-system and multi-agency data accuracy attained through the data sharing agreement. Future hopes for greater data integration leading to a "data-ecosystem".



Future Hopes: Resources

POLICY ANALYST/Grants

Coordinator

Focus on Re-Entry subcommittee; grants development and administration; assist in other duties Dane County is well positioned to compete for national grants as a well known entity for collaborative, committed stakeholders, inspired residents, innovative ideas, and accurate data.



2025 Budget

Adherence to the County Executive Guidelines

Two decision items to enhance current OJR responsibilities, focused on the Dane County Community Court.

In 2022, Dane County won a federal grant for 600K to plan and implement a community court focused on racial equity and procedural fairness.

Decision items for OJR

1. Data Enhanced Pilot Community Court: Community Court Case Management Software–Initializing the Community Court with effective software to assist in case management, data accuracy, and court reporting requirements to local and federal officials and community members.

2. **Peer Learning from the Experts:** Reallocation of membership fees to conference and training expense due to emerging community court of Dane County onboarding and peer site court events and conferences.

Engagement and Communication with community, focus underserved communities

Past Efforts

CJC-Behavioral Health survey of those with SUD, Beh Health concerns and justice involvement; co-authored by member with lived experience

CJC Community Conversations

Intentional engagement and partnership with advocacy agencies and those with lived experience.

Future Efforts (2025)

Community engagement-strategic plan for CJC and subcommittees

Craft position description to include those with lived experience; peer advocates

Ask and survey those with lived experience in courts, behavioral health, and criminal justice -baseline/future.

Strategic Engagement and Outreach Specialist

Partnership in already existing advocacy groups

Develop new partnerships with community, researchers, and new stakeholders



Authentic Engagement

Building a justice system that meets the needs of community members and community health requires a commitment to engaging people that are genuine, meaningful, and build trust by action based on input.
