My additional comments to these would be we are still having his trucks go down to the east. As recently as June 25th. My comment to his Ms Steffies is, that she does NOT reside on Wilkinson Rd and have to deal with his growing company. When he originally proposed his "family" business he told the town board he does not see it getting larger. Yet here we are again. Please take a look at the pictures of the size of the trucks and the size of the road. Landscape companies of his size are found with direct access to major highways, not rural roads. For over 35 years we have seen the same pattern of asking for forgiveness for violations claiming ignorance.

I am Carmen Schultz and I live east of Andrews Horticulture business. I am here because I am concerned about changes to the companies current CUP. A CUP that came about because of zoning violations regarding establishing a business, violations of construction of buildings without permits. The annual review of the CUP was meant to address yearly the concerns of neighbors and the impact of the business to neighbors. Even when concerns (violations) were raised previous boards dismissed them. Yet here we are again with Tim violating zoning, threatening the watershed with manure runoff, and asking for forgiveness and claiming ignorance. He stated at last months meeting he has already started to prepare an area for another building - without approval. How many times before he gets told no? In looking at other landscape companies, they are found in non residential areas with access to major roads such as Mineral Point Rd, Verona Rd, and Hwy 14.

When the original CUP was passed, a business driveway was established to eliminate traffic on the corner. Now he has connected the business driveway to the residential driveway to access Wilkinson with vehicles, creating again a hazardous situation.


A frequent CUP violation is vehicles travelling east on Wilkinson Rd to Dunlap Hollow Rd to Katzenbuechel Rd, Hwy KP and finally onto Hwy 12. This is 3.5 miles on narrow country roads with hills, 90 degree turns and blind corners. The CUP states he should travel the .7 miles WEST on Wilkinson Rd to Hwy 78.

After talking to the DNR regarding an ongoing issue, it was suggested to place camera's to try and catch the offender. When the individual who placed the camera's took them down, he commented most of what he saw were Tim's trucks and equipment .So I looked at some of the pictures and documented them from the end of October to beginning of February, EVEN after the CUP renewal. .

I did not include when lone pickups, even with tools, box truck with chips only. In that brief time period, "slow period" for landscaping almost 80 trips. Look how much these trucks take up on Wilkinson Rd. The last page has 2 small SUV passing each other, note they are both on the edge of the blacktop. When encountering these large trucks you <u>always</u> have to go off road.

The final picture I will show you is from January 22, post CUP renewal.

PLEASE do not allow him to expand, he stated in his original CUP application there would be no need. If he needs more space he needs to find another place for his business. His repeated history of violating the CUP and zoning should be enough to deny this.
