2024 RES-199 AUTHORIZING THE RECLASSIFICATION OF A 1.0 FTE CLERK I-II TO A 1.0 FTE CLERK III FOR THE HENRY VILAS ZOO

Policy Analysis Statement:

Brief Description of Proposal -
 The Henry Vilas Zoo has a vacant 1.0 FTE Clerk I-II position (#1540) which we requested to be reclassified to a 1.0 FTE Clerk III position. This vacant position has been open since June of 2024 due to the employee transferring to a different Dane County department.

Current Policy or Practice -
 This position supports all zoo departments and their employees.

Impact of Adopting Proposal -
 The requested reclassification will strengthen the zoos internal effectiveness to support its' growing team while increasing its' ability to serve the community and new partners. This reclassification will also aid in how the zoo functions with all other County departments (e.g. ER, HR, Purchasing, and Controller).
