Dear Mr. Lane,

Dan Everson's letter to Mr. Hahn on July 29th offered a clear solution to the ongoing truck traffic issue. He wrote:

"The operator should discontinue the acceptance of any material to the site in order to reduce truck traffic to a reasonable level."

Despite this recommendation, truck traffic has not slowed. Many neighbors continue to see loaded trucks entering the quarry and leaving empty, as well as empty trucks entering and leaving fully loaded. It is no surprise, then, that our local roads are showing increased wear and tear. By allowing the owner of the quarry to take in fill, it only adds to more truck traffic and obviously the owner isn't taking Mr. Everson's solution to heart or doesn't understand it, as that will probably be his excuse.

Just yesterday, I received a text from a friend describing these same concerns. I am withholding her name because, like many of us in the area, she fears retaliation.

"FYI: My husband was at our church in Madison all day. The old blacktop and 3 ft of stone, soil, etc was loaded on dump trucks and guess where they were going?? My husband asked and was told K&D stone. There were always 7 dump trucks waiting to be loaded with debris."

My question is, when Mr. Everson stated "a reasonable level," what exactly does that mean? Does it mean that having seven dump trucks continuously waiting to be filled with demolition debris and then driving all the way from Madison to our local roads to dump at the neighborhood quarry is considered reasonable?

I really do not enjoy writing to you about these matters and I know you have much more important issues to deal with, but it is frustrating, not only for me but for my entire neighborhood. I visited a neighbor recently that is having some health issues and is going through chemotherapy right now. When I went to check up on him and asked how he was doing, he didn't even talk about the challenges that his cancer treatment was giving him. He talked about the non-stop truck traffic that was causing him distress. It saddened me.

Thank you for listening to my concerns. I know your job must be thankless at times, and I just wanted to let you know that you are appreciated.
