Brief Description of Proposal -

A rail to trail conversion is the most efficient route for achieving the goal of a regional bicycle/pedestrian trail from the Wisconsin River (and existing trails in Sauk County) towards the Village of Mazomanie. The documents authorized by this resolution are a required part of the process for Dane County to assume responsibility of the rail corridor for purposes of building and maintain a regional bicycle/pedestrian trail.

Current Policy or Practice -

Aquisition of property or property interests requires County Board approval. These documents obligate the County to take on responsibilities for the trail corridor that are consistent with ownership.
