Pursuant to Marsy's Law constitutional mandates and continuing to manage the COVID-19 backlog, the following positions are needed:

- Paralegal I 1 FTE Position (\$110, 600)
- Clerk III Deferred Prosecution Program (Additional \$68,308)
- Case Manager for Deferred Prosecution Program (Additional \$75,956)
