19	(c) Effective with the third Tuesday in April 2026, county board supervisors
20	shall receive an annual salary of \$12,571.56.
21	(ed) In addition to the salary set forth above, with the exception of the
22	Executive Committee, supervisors who serve as chair of a standing committee or
