## AUTHORIZING AN AGREEMENT TO HOUSE RELOCATED DANE COUNTY JAIL RESIDENTS TO THE IOWA COUNTY JAIL

 The Sheriff's Office contracts with Iowa County to provide bed space and maintenance for residents committed to the Dane County Jail who are relocated and housed in the Iowa County Jail. In August 2022, the Sheriff's Office began relocating jail residents to other county jails. The need to house Dane County jail residents at other county jails with adequate available space arose due to the closure of the east section of the 7<sup>th</sup> floor of the City-County Building Jail.

This addendum seeks authorization to extend the term of Contract # 15024 from January 1, 2026, through December 31, 2026, for lowa County Jail to make bed space available for Dane County Jail Residents. Iowa County will provide bed space for a minimum of twenty-five (25) residents and a maximum of thirty-five (35) residents. The rate will be \$60 per day per resident, totaling \$771,700, including \$5,200 for pharmaceutical costs.

The daily cost is computed based on bed space and maintenance furnished by the lowa County Jail, as determined by the actual number of residents housed by the lowa County Jail per day. Funding for jail resident housing relocation was approved in the 2025 budget, and its continuation was approved in the 2026 budget.

**NOW, THEREFORE, BE IT RESOLVED** that the County Executive and the Dane County Clerk are hereby authorized to execute, on behalf of the County of Dane, an addendum to extend the term of Contract #15024 from January 1, 2026 through December 31, 2026, at a cost of \$771,700 to house relocated Dane County Jail residents at the Iowa County Jail through 2026.



# DANE COUNTY CONTRACT ADDENDUM # 15024D

**THIS ADDENDUM**, made and entered into effective as of the date by which both parties hereto have signed this document, by and between the County of Dane (hereinafter referred to as "County") and Iowa County, WI (hereinafter, "Provider").

#### WITNESSETH:

WHEREAS, Provider and County, through a separate document (hereinafter referred to as the "Master Agreement"), Dane County Contract #15024, have previously established a contractual relationship under which Provider supplies bed space and maintenance for residents committed to the Dane County Jail, and

**WHEREAS** County and Provider wish to amend the Master Agreement to extend the contract term from January 1, 2026, through December 31, 2026, at a total contract cost of \$771,700, which includes up to \$5,200 for pharmaceutical expenses.

**NOW, THEREFORE**, in consideration of the above premises and the mutual covenants of the parties set forth below, each party hereby acknowledges receipt and sufficiency of this consideration. The parties agree as follows:

- 1. The Master Agreement shall remain in full force and effect unchanged in any manner by this addendum except as changes are expressly set forth herein. This addendum shall control only to the extent of any conflict between the terms of the Master Agreement and this addendum.
- 2. The Master Agreement, and any amendment or addendum to it, may be executed and transmitted to any other party by legible facsimile reproduction or by scanned legible electronic PDF copy, and utilized in all respects as an original, wet-inked, manually executed document. Further, the Master Agreement and any amendment or addendum thereto may be stored and reproduced by each party electronically, photographically, by photocopy or other similar process, and each party may, at its option, destroy any original document so reproduced. All parties hereto stipulate that any such legible reproduction shall be admissible in evidence as the original itself in any judicial, arbitration, or administrative proceeding, whether or not the original is in existence and whether or not each party made such reproduction in the regular course of business. This term does not apply to the service of notices under the Master Agreement, or any subsequent amendment or addendum.
- 3. The term of the contract is extended through December 31, 2026, for \$771,700, enabling the Provider to make bed space available to the County daily for a minimum of twenty-five (25) residents and a maximum of thirty-five (35)

- residents, including \$5,200 for pharmaceutical costs from January 1, 2026, through December 31, 2026.
- 4. Cost is based on a rate of \$60 per day and is computed on bed space and maintenance provided by Provider based on the actual number of residents housed by the Provider per day.
