**AUTHORIZING HIGHWAY SAFETY GRANT FUNDING FOR A SPEED ENFORCEMENT  
TASK FORCE PROJECT**

The Department of Transportation, Bureau of Transportation Safety, State of Wisconsin, is making funds available for participation in a 2024-2025 Speed Enforcement Task Force Project, Grant Number SPD-2025 DANE CO SO-00052; total grant funding of \$113,000 to be allocated to Dane County and the Madison Police Department at \$56,500 each, grant project period is October 1, 2024 through September 30, 2025.

The goal of this federally funded enforcement project is to reduce traffic crashes in Dane County by focusing on speeding violations, aggressive driving, and seatbelt violations. Excessive speed is often associated with other high-risk behaviors including following too closely and failure to wear safety belts which increase the likelihood of a crash, significant injury, and fatalities.

Participating agencies in this enforcement task force effort include the Dane County Sheriff's Office and Madison Police Department. The Dane County Sheriff's Office will be the administrator of this grant, collecting data from both agencies and filing a single report with the State of Wisconsin.

**NOW, THEREFORE, BE IT RESOLVED** that the Sheriff's Office is hereby authorized to accept \$113,000 from the Department of Transportation, Bureau of Transportation Safety, for the Speed Enforcement Task Force Project Grant and on behalf of the County of Dane, the County Executive is authorized to execute an agreement embodying the above provisions; and

**BE IT FURTHER RESOLVED** that \$113,000 is appropriated as additional revenue in the Sheriff's Office, Field Services, Speed Task Force revenue account (SHRFFLD-80673) and is credited to the General Fund; and

**BE IT FURTHER RESOLVED** that \$113,000 is transferred from the General Fund to the following budget account lines:

**BE IT FINALLY RESOLVED** grant funds not expended as of December 31, 2024 be carried forward until fully expended.
