1.Bock Foundation Grant - No update. The grant submitted by the Tree Board was for funding an outside consultant to help create a tree preservation resolution.

1.Review/Add/Edit Dane County Tree Policy Resolution ingredients for forwarding on at the conclusion of the meeting. The subcommittee met, progress was made on deciding what to put in a resolution and the resulting document is on Google Drive for viewing and editing. Discussed current document.

2. TB Parks and Open Space Plan comments: BOSCI reviewed the Dane County Parks' Open Space Plan, grouped topics together and presented her findings to the Board for discussion, with Board input to be submitted back to Parks. Discussion: Noted lack of other forested lands preservation other than in the two mentioned parks in the plan. Bosci suggested adding statements for protecting other forests as well, including comments on heritage trees, replanting requirements when trees are removed, mitigating tree damage, etc. She also suggested statements on where to restore to pre-settlement vegetation versus where to adapt the plant palette for climate change in terms of species, incorporating risk assessments for trees in highly trafficked areas, and a process for determining when to have a forest management plan.

ERKER MOTIONED that BOSCI'S summary goes out for final comments from Board members for one week and after that it goes out as is to Parks. MOTION was seconded WEISS. MOTION passed by voice vote (5-0).
