Chair Miles and Supervisor Chawla both responded with information regarding county actions and initiatives, such as removal of legacy phosphorus, nutrient management, lake weed cutting in targeted navigation channels, etc. They also mentioned that progress is cyclical because of complex and dynamic factors such as seasonal weather events, climate change, etc.
