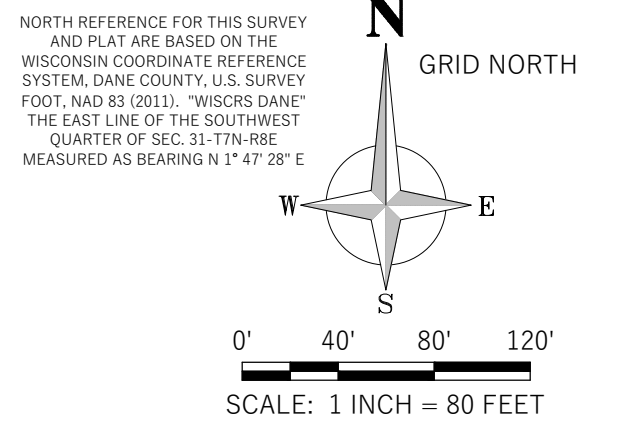


# PRELIMINARY PLAT of TIMBER LANE PRESERVE

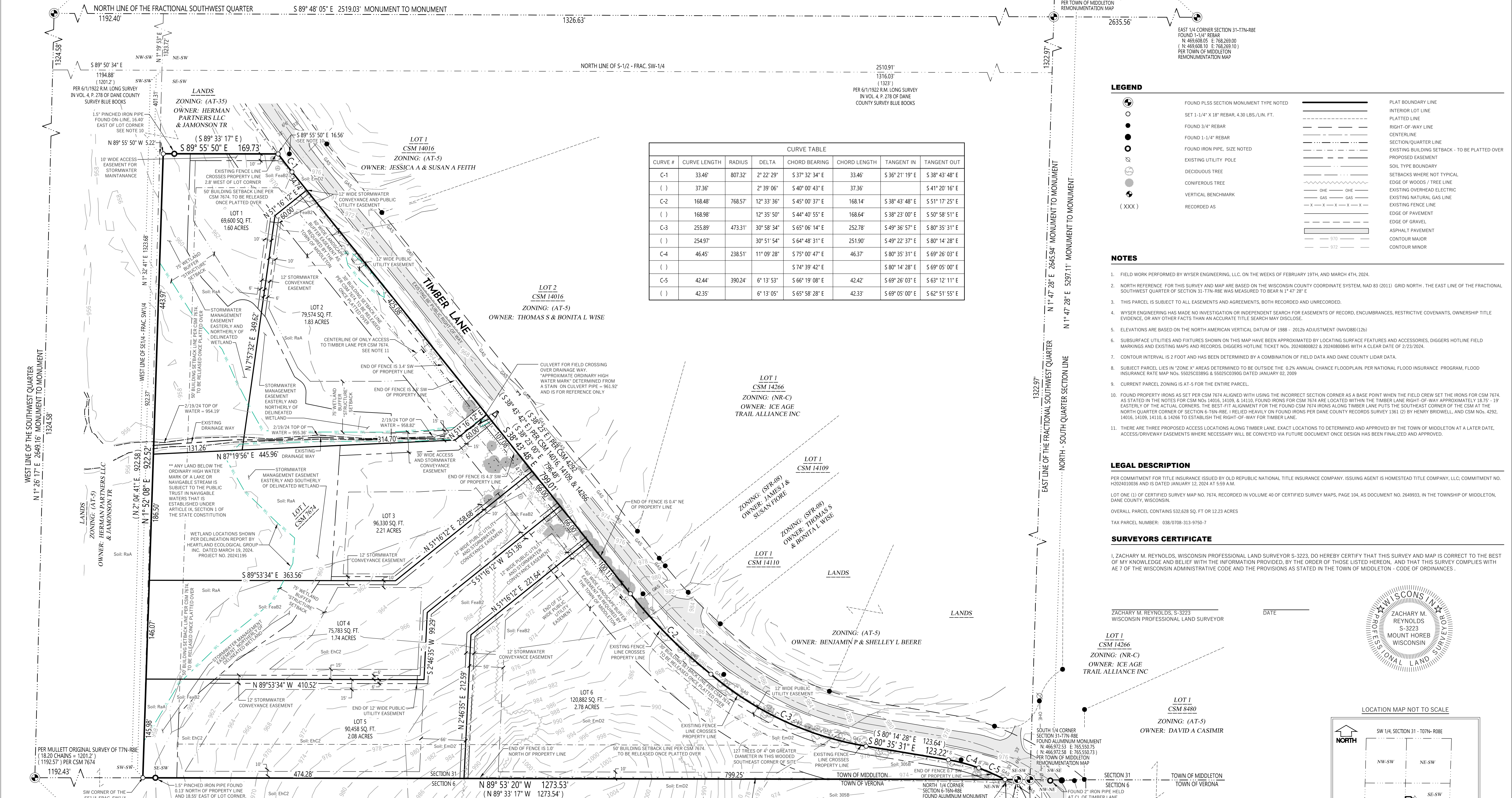


WEST 1/4 CORNER SECTION 31-T7N-R8E

- NORTH REFERENCE FOR THIS SURVEY AND MAP ARE BASED ON THE WISCONSIN COUNTY COORDINATE SYSTEM, NAD 83 (2011) GRID NORTH. THE EAST LINE OF THE FRACTIONAL SOUTHWEST QUARTER OF SECTION 31-T7N-R8E WAS MEASURED TO BEAR N 1° 47' 28" E.
- THIS PARCEL IS SUBJECT TO ALL EASEMENTS AND AGREEMENTS, BOTH RECORDED AND UNRECORDED.
- WYSER ENGINEERING HAS MADE NO INVESTIGATION OR INDEPENDENT SEARCH FOR EASEMENTS OF RECORD, ENCUMBRANCES, RESTRICTIVE COVENANTS, OWNERSHIP TITLE EVIDENCE, OR ANY OTHER FACTS THAN AN ACCURATE TITLE SEARCH MAY DISCLOSE.

- SUBJECT PARCEL LIES IN "ZONE X" AREAS DETERMINED TO BE OUTSIDE THE 0.2% ANNUAL CHANCE FLOODPLAIN, PER NATIONAL FLOOD INSURANCE PROGRAM, FLOOD INSURANCE RATE MAP NOS. 55025C0389G & 55025C0390G DATED JANUARY 02, 2009.
- CURRENT PARCEL ZONING IS AT-5 FOR THE ENTIRE PARCEL.
- FOUND PROPERTY IRONS AS SET PER CSM 7674 ALIGNED WITH USING THE INCORRECT SECTION CORNER AS A BASE POINT WHEN THE FIELD CREW SET THE IRONS FOR CSM 7674, AS STATED IN THE NOTES FOR CSM NOS. 14010, 14109, & 14110. FOUND IRONS FOR CSM 7674 ARE LOCATED WITHIN THE TIMBER LANE RIGHT-OF-WAY APPROXIMATELY 18.75' - 19' EASTERLY OF THE ACTUAL CORNERS. THE BEST-FIT ALIGNMENT FOR THE FOUND CSM 7674 IRONS ALONG TIMBER LANE PLATS THE SOUTHEAST CORNER OF THE CSM AT THE NORTH QUARTER CORNER OF SECTION 6-T6N-R8E. I RELIED HEAVILY ON FOUND IRONS PER DANE COUNTY RECORDS SURVEY 1361 (2) BY HENRY BRIDWELL, AND CSM NOS. 4292, 14016, 14109, 14110, & 14266 TO ESTABLISH THE RIGHT-OF-WAY FOR TIMBER LANE.
- THERE ARE THREE PROPOSED ACCESS LOCATIONS ALONG TIMBER LANE. EXACT LOCATIONS TO DETERMINE AND APPROVED BY THE TOWN OF MIDDLETON AT A LATER DATE. ACCESS/DRIVEWAY EASEMENTS WHERE NECESSARY WILL BE CONVEYED VIA FUTURE DOCUMENT ONCE DESIGN HAS BEEN FINALIZED AND APPROVED.

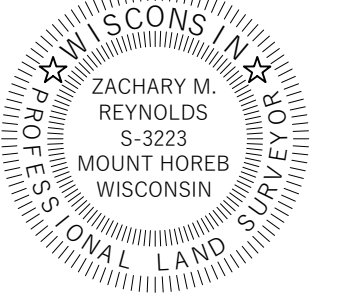

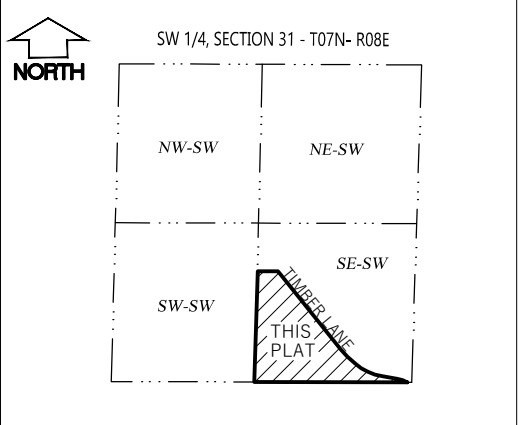
