Brief Description of Proposal -

The Department of Transportation, Bureau of Transportation Safety, State of Wisconsin, is providing \$179,000 grant funding for participation in a 2025/2026 Impaired Driver Enforcement Project, Grant Number IDE-2026-DANE CO SO-00236; grant project period is October 1, 2025 through September 30, 2026; the Sheriff's Office shall receive \$89,500 and the Madison Police Department shall receive \$89,500 grant funding.

Current Policy or Practice -

Acceptance of grant funding requires approval of the County Board.

Impact of Adopting Proposal -

In Wisconsin during 2024, alcohol was listed as contributing factor in vehicle crash deaths. Data from the Wisconsin Department of Transportation (WisDOT) indicates that 27% of fatal crashes in 2024 involved an impaired driver, with factors like alcohol and speeding often overlapping.
