Policy Analysis Statement:

Brief Description of Proposal -

A 0.5 FTE position (#243) will be vacated in the Crime Response Program commencing 4/7/25. The program currently supports two 0.7 positions. All positions share a common class specification and position description. The Crime Response Program proposes to assign 0.3 FTE to position #2999 and 0.2 FTE to position #3051.The positions were originally designated part time due to limits on available grant funds.

Current Policy or Practice -

The Program sought approval from DOA, the impacted employees, and the employee group.

Impact of Adopting Proposal -

Increasing the FTE of existing positions immediately enhances the productivity of the unit vs.recruiting, hiring and training another part-time employee.
