C. Discussion Items

Dementia Tool - Joy Schmidt

Joy Schmidt works for Dane County Adult Protective Services. Dementia Crisis role created in 2020 to have a preventative role in protective services. Providers can go through the helpline that is on their website to report any concerns they have when responding to a patient with suspected dementia. Investigators are able to help if it is a self-neglect concern. Flyer explains Dementia Crisis program, tips, and information about dementia that is educational for EMS staff but could also be left with families of patients. First Responder tool is available on website and is a fillable PDF for patient information to be entered. This form can be filled out and be available at the home of a patient for responders to get their information easier (medical conditions, allergies, medications, etc.). Responders could encourage the family/caregivers to fill out the form. This tool had been previously shared with "Memory Cafes" pre-Covid, but could be shared once more as a reminder since it has been a while. There are also sensory kits with supplies/toys to help calm patients that Joy will look at potentially funding.

Staff Signatures at Transfer of Care - Kim Stanley

Kim Stanley from EMS Management and Consultants discusses the importance of EMS staff getting signatures following care of a patient. Provisions are in place for incidents when patients are unable to sign for themselves. Patient can sign themselves, or if they are unable to sign, their authorized representative should sign on the patient's behalf. If they are unable to sign or refuse to sign, box 3 on signature form must be completed for agency to bill the patient. This includes reason patient was not able to sign, facility transported to, crewmember signature and receiving facility signature. The issue being seen in EMS is that crews are not getting full name of hospital representatives signing and can not enter the name in the report. Guidance currently states that a legible first initial and last name is required. May need additional training for ED staff to understand why their last name is needed. Can follow up at a future MAS meeting to see if there is any additional steps to be taken.

MFD Buprenorphine Update - Dr. Gussick

Group got update from Dr. Gussick on how the MFD Buprenorphine program has gone since its launch. Since March 1st, there have been 10 cases of buprenorphine administered in the field. There have been a couple patients that called with withdrawal symptoms. All patients have been transported to hospitals after receiving buprenorphine. Dr. Gussick plans to follow up with community medics on a complete review of their experiences. Will likely need additional education for ED's. Patients overall have not gotten great direction from hospitals on follow-up. Community medics have volunteered to do a 30-day follow up phone call that will hopefully be implemented soon. Dr. Gussick and Kailey Peterson sat down and talked to jail staff about continuing buprenorphine treatment if patients are taken to jail. If anyone experiences issues with patients not getting continued buprenorphine treatment, let Dr. Gussick and Kailey Peterson know so they can follow up. A request was made for Dr. Gussick to follow up with Medical Advisors on cases where patients received care at their respective hospitals.

Dane County EMS Protocols

Measles Update

One case confirmed in Dane County has resulted in about 1,000 contact follow ups total. Some infants are still in quarantine due to being too young for the vaccine. Pediatric specialists are not recommending early MMR vaccine for kids under 4 yet; may reconsider if case numbers increase significantly. If patient is confirmed positive or is symptomatic and has a confirmed exposure, ambulance should be taken out of service and ventilated for at least 2 hours. During radio report, EMS personnel should report to hospital if transporting a known measles positive patient.

EMS Week next week with hospitals and EMS office offering food on different days next week. Survivor Celebration on June 1st has 12 survivors attending. Ceremony starts at 4pm, game start time 6:05pm.
